

RESOLUTION OF THE
NAABIK'ÍYÁTI' STANDING COMMITTEE
25th NAVAJO NATION COUNCIL -- First Year, 2023

AN ACTION RELATING TO THE NAABIK'ÍYÁTI' COMMITTEE; APPROVING AND RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2024 BUDGET FOR THE NAVAJO NATION EXECUTIVE OFFICES AND RELATED MATTERS, TO BE INCLUDED IN THE NAVAJO NATION'S FY2024 COMPREHENSIVE BUDGET

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council with 2 N.N.C. § 700(A).
- B. The Naabik'íyáti' Committee is the oversight committee for the Navajo Nation Executive Offices. 12 N.N.C. § 840(A).
- C. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budgets of the programs under its oversight responsibility. 12 N.N.C. § 840(A).

SECTION TWO. FINDINGS

- A. The oversight committee recommendations shall not exceed the base planning amounts established by the Budget and Finance Committee. 12 N.N.C. § 840(A).
- B. The Naabik'íyáti' Committee held meeting(s) and heard report(s) from Program staff and the Office of Management and Budget regarding the proposed FY2024 Budget for the Navajo Nation Executive Offices. 12 N.N.C. § 840(A).
- C. The Naabik'íyáti' Committee finds that approval of the proposed FY2024 Budget for the Navajo Nation Executive Offices and inclusion of such Budget in the Navajo Nation's FY2024 Comprehensive Budget is in the best interest of the Navajo Nation.

SECTION THREE. APPROVING AND RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2024 BUDGET FOR THE NAVAJO NATION EXECUTIVE OFFICES AND RELATED MATTERS


- A. The Naabik'íyáti' Committee hereby approves the FY2024 Budget for the Navajo Nation Executive Offices as detailed in the "Fund Type Budget Summary," attached hereto as Exhibit A.
- B. The Naabik'íyáti' Committee hereby approves certain revisions, if needed, to the Branch Chiefs' proposed FY2024 Budget amount for the Navajo Nation Executive Offices, as shown in Columns D and E in the "General Fund Comparative Summary" attached hereto as Exhibit B.
- C. The Naabik'íyáti' Committee recommends the changes, if needed, to the General Fund Budget described in Exhibit C.
- D. The Naabik'íyáti' Committee recommends certain Conditions of Appropriation and Legislative Concerns, if needed, as listed in Exhibit D.
- E. The Naabik'íyáti' Committee recommends that certain Unmet Needs for the Navajo Nation Executive Offices, if needed, be included in the FY2024 Comprehensive Budget, as explained in Exhibit E.
- F. The Naabik'íyáti' Committee hereby recommends that the Budget and Finance Committee approve the Navajo Nation Executive Offices FY2024 Budget and all Naabik'íyáti' Committee recommendations, as set forth in Exhibits A - E.
- G. As necessary and appropriate, the Naabik'íyáti' Committee hereby authorizes the Chairperson, or member of the Committee, to negotiate the Naabik'íyáti' Committee recommendations herein with the Budget and Finance Committee.

SECTION FOUR. EFFECTIVE DATE

This Action shall become effective as provided in 2 N.N.C. § 189 (A).
