PURPOSE: The purpose of this legislation is to amend the Navajo Nation Code so that same sex marriages executed in other jurisdictions are recognized within the Navajo Nation.


This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

21 SECTION ONE. AUTHORITIES

- 22 A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §
23 102(A).
- 24 B. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation Council
25 empowered to review proposed legislation which requires final action by the Navajo
26 Nation Council. 2 N.N.C. §§ 700(A), 164(A)(9).
- 27 C. The Health, Education and Human Services Committee is a standing committee of the
28 Navajo Nation Council empowered [t]o establish Navajo Nation policy, promulgate
29 rules and regulations governing health, social services, education, human services and
30

1 general government services of the Navajo Nation and its tribal organizations, entities,
2 and enterprises. 2 N.N.C. §§ 400(A), 401(B)(1).

3 D. The Law and Order Committee is a standing committee of the Navajo Nation Council
4 empowered [t]o review and make recommendations to the Navajo Nation Council on
5 proposed amendments to and enactments in the Navajo Nation Code. 2 N.N.C. §§
6 600(A), 601(B)(14).

7 E. The Budget and Finance Committee is a standing committee of the Navajo Nation
8 Council empowered to [t]o promulgate policies and regulations concerning wages,
9 expenditure reimbursement, and fringe benefits for Navajo Nation officials and
10 employees. 2 N.N.C. §§ 300(A), 301(B)(8).

11
12 **SECTION TWO. FINDINGS**

13 A. Over the past century, the Navajo Nation Council, as the Navajo Nation's governing
14 body, has exercised the Navajo Nation's inherent sovereign power to establish statutory
15 laws and regulations relating to domestic relations within the Navajo Nation, including
16 CJ-2-40, CJL-3-44, CF-2-54, CJ-42-56, CO-54-56, CAP-3-93, and CAP-29-05/CJN-
17 34-05.

18 B. In 2005, the 20th Navajo Nation Council enacted Resolution No. CJN-34-05 which
19 provided that, "[m]arriage between persons of the same sex is void and prohibited". 9
20 N.N.C. § 2(C). Almost twenty years later, the 25th Navajo Nation Council recognizes
21 that the prohibition against same sex marriage does not uniformly welcome or support
22 the well- being of *all* Diné.

23 C. The purpose of this legislation is to repeal 9 N.N.C. § 2(C) of the Diné Marriage Act
24 of 2005 to ensure that all Diné are welcome within the four sacred mountains and to
25 uniformly recognize all marriages within the Navajo Nation. This legislation also
26 amends other provisions within the Navajo Nation Code to conform with this repeal:
27 9 N.N.C. § 4(E)—Common Law Marriage, 9 N.N.C § 7—Marriage License, and 9
28 N.N.C. § 201 et. seq.

29 D. Through this legislation, the Navajo Nation will exercise its inherent sovereign power
30 in regulating domestic relations by repealing 9 N.N.C. § 2(C) which provides,

1 “[m]arriage between persons of the same sex is void and prohibited.” The Diné
2 Marriage Act of 2005 explicitly excluded and prohibited members of the same-sex
3 from marrying. This legislation also amends other necessary provisions within the
4 Navajo Nation Code to conform with this repeal.

5 E. Although this legislation repeals the prohibition against same-sex marriage at 9 N.N.C.
6 § 2(C), the method for a traditional Navajo wedding ceremony outlined at 9 N.N.C §
7 4(D) involving a man and a woman shall remain unchanged. Traditional Navajo society
8 places a great importance upon the institution of marriage and believes that the
9 elaborate ritual of marrying using the traditional method is believed to be blessed by
10 the “Holy People.” This blessing ensures that the marriage will be stable, in harmony,
11 and perpetual. *Navajo Nation v. Murphy*, 6 Nav. R. 10, 13 (1988); *See also Begay v.*
12 *Chief*, No. SC-CV-08-3, 8 Nav. R. 654 (2005), which provides that common law-
13 marriage under Navajo Nation Code is different than one arising out of traditional
14 wedding ceremony. Keeping the traditional Navajo wedding the same will not prohibit
15 nor deny same-sex marriage because there are other methods available for marrying
16 under 9 N.N.C § 4.

17 F. The Navajo Nation also recognizes that in *Obergefell v. Hodges*, the Supreme Court of
18 the United States ruled that “[t]he right to marry is a fundamental right inherent in the
19 liberty of the person, and under the Due Process and Equal Protection Clauses of the
20 Fourteenth Amendment, couples of the same sex may not be deprived of that right and
21 that liberty.” *Obergefell v. Hodges*, 135 S.Ct. 2584, 2591 (2015). The Navajo Nation
22 understands that it has inherent powers to govern domestic relations and is not bound
23 by the decision in *Obergefell v. Hodges*. *See also Talton v. Mayes*, 163 U.S. 376 (1896).
24 However, the Navajo Nation, through this legislation, is uniformly recognizing all
25 marriages for any tribal member to marry any person of their choice within the Navajo
26 Nation.

27 G. The Navajo Nation further recognizes that Navajo society accepted multi-gendered
28 individuals prior to European arrival. European religious influence viewed
29 homosexuality as an intolerable sin. As a result, acceptance of the lesbian, gay, bisexual,
30

1 transgender, questioning/queer, two-spirit (LGBTQ+) declined within tribal nations.
2 Today, many tribal nations have repealed same-sex prohibition laws.

3 H. The Navajo Nation passed Resolution No. NABIS-50-19 supporting the U.S. Congress
4 to enact Senate Bill 788, "Equality Act." The Equality Act will amend the Civil Rights
5 Act of 1964, to expand and clarify the protections and remedies against discrimination
6 on the basis of sexual orientation, gender identity, and sex in the areas of employment,
7 housing, public, accommodations, public education, federal funding, credit, and the jury
8 system.

9 I. The 24th Navajo Nation Council also passed Resolution No. CJY-63-20 which
10 established Diné Pride Week to be held every third week in June as a recurring event.
11 Through CJY-63-20, the Navajo Nation proclaimed that the "Nation will continue to
12 protect its citizens from discrimination based on age, race, disability, ethnicity, family or
13 marital status, gender identity or expression, languages, national origin, physical and
14 mental ability, religion, sexual orientation, veteran status and other characteristics that
15 make our citizens unique under the law."

16 J. Data has also shown that LGBTQ+ members experience higher rates of workplace
17 discrimination and non-acceptance from family members which leads to increased
18 substance abuse and suicide attempts as well as other mental health effects. Further data
19 shows, providing support for LGBTQ+ decreases the negative effect and promotes self-

24 K. Navajo culture from time of immemorial express oral stories about multiple gendered
25 people. Multiple gendered people have always been acknowledged and have also played
26 important roles in our history.

27 L. In 2005, the sponsor of the Diné Marriage Act of 2005 expressed that its purpose was to
28 "promote strong families and strong family values, not discriminate." This repeal will
29 also ensure same-sex couples are included and recognized in promoting strong families
30 through adoption if the same-sex couple decide to adopt. Additionally, the Naabik'iyáti'

1 Committee of the 24th Navajo Nation Council passed Resolution No. NABIMY-14-22 to bring
2 awareness of Navajo foster children being placed in foster care across tribal communities and the
3 United States. Resolution No. NABIMY-14-22 also brought awareness that there is a need for
4 more Navajo foster parents.

- 5 M. The Navajo Nation finds it to be in the best interest of the Navajo Nation and the Navajo
6 People to repeal 9 N.N.C. § 2(C) so that all persons can enjoy the full benefits of legal
7 recognition of their marriages within the Navajo Nation, whether our relatives are
8 heterosexual, homosexual, bisexual, transgender, non-gender specific, two-spirit,
9 nadleeh.

11 **SECTION THREE. REPEALING 9 N.N.C. § 2(C) OF THE DINÉ MARRIAGE ACT**
12 **OF 2005**

13 The Navajo Nation hereby amends 9 N.N.C. § 2(C) as set forth below.

- 20 A. All plural marriages contracted, whether or not in accordance with Navajo custom, shall
21 be void and prohibited.

23 every degree, between brothers and sisters of one-half degree, as well as whole blood,
24 and between uncles and nieces, aunts and nephews and between first cousins, is
25 prohibited and void.

**SECTION SIX. AMENDING HUSBAND AND WIFE SECTION AT 9 N.N.C. § 201 *ET.*
*SEQ.***

The Navajo Nation hereby amends 9 N.N.C. § 201 *et. seq.* as follows:

Title 9. Domestic Relations

Chapter 3. ~~Husband and Wife~~ Property Rights and Liability

§ 202. Separate property—Definitions

- A. All property, real and personal, of both spouses ~~the husband~~, owned or claimed by him or her before marriage, and that acquired afterward by gift, devise or descent, and also the increase, rents, issues and profits thereof, is his or her separate property.
- ~~B. All property, both real and personal, of the wife, owned or claimed by her before marriage, and that acquired afterward by gift, devise or descent, and also the increase, rents, issues and profits thereof, is her separate property.~~

1 ~~CB.~~ The earnings and accumulations of the ~~wife~~ spouse and the minor children in his or her
2 custody while he or she lives separate and apart from his or her spouse ~~husband~~ are the
3 separate property ~~of the wife~~.

4
5 **§ 203. Liability for debts**

6 The separate property of ~~the husband or wife~~ either spouse is not liable for the debts of the
7 other contracted before marriage or contracted after separation.

8
9 **§ 204. Married women couple**

10 Married ~~women~~ couples have the sole and exclusive control of their separate property. The
11 separate property of a married ~~woman~~ spouse is not liable for the debts or obligations of the
12 other spouse ~~husband~~, and it may be sold, mortgaged, conveyed or bequeathed by ~~the woman~~
13 either spouse who owns it as if he/she were not married

14
15 **§ 205. Community property—Definition**

16 A. All property acquired by either ~~husband or wife~~ spouse during the marriage, except that
17 which is acquired by gift, devise or descent, or earned by ~~the wife~~ either spouse and her
18 ~~minor children~~ while he or she lives separate and apart from his or her husband spouse, is
19 the community property ~~of the husband and wife~~.

20 B. Separate property comingled with community property is still separate if it can be clearly
21 traced and identified.

22 ****

23 **§ 207. Personal property; disposition**

24 During ~~coverture~~ marriage, community personal property may be disposed of by both parties
25 consenting ~~the husband only~~.

26
27 **§ 208. Liability for community debts**

28 The community property of ~~the husband and wife~~ either spouse is liable for the community
29 debts contracted by his or her spouse ~~the husband~~ during marriage unless specially excepted
30 by law.

1
2 **§ 209. Legal capacity of married women—Generally**

3 Married women of the age of ~~21~~ 18 years and upwards have the same legal rights and are
4 subject to the same legal liabilities as men of the age of ~~21~~ 18 years and upwards ~~except the~~
5 ~~right to make contracts binding the common property of the husband and wife.~~

6
7 **~~§ 210. Necessaries—Power of wife to contract debts~~**

8 ~~The wife may contract debts for necessaries for herself and her children upon the credit of her~~
9 ~~husband.~~

10
11 **§ 210. Action to collect debt; order of execution**

12 In an action to collect a debt ~~for necessaries for the wife and her children, the~~ both spouses
13 ~~wife and her husband~~ shall be sued jointly and severally and the court shall decree that
14 execution be levied first upon the ~~common~~ community property, secondly upon the separate property
15 of each spouse. ~~the husband and third upon the separate property of the wife.~~

20 **SECTION SEVEN. DIRECTIVES**

21 All divisions, departments, programs, and offices of the Navajo Nation government shall
22 amend their policies, including but not limited to employee benefits, to reflect and include
23 changes set forth in this legislation within ninety (90) days after enactment of this legislation.

24
25 **SECTION EIGHT. EFFECTIVE DATE**

26 This legislation and the Navajo Nation Code amendments enacted herein shall become
27 effective pursuant to 2 N.N.C. § 221(B).

28
29 **SECTION NINE. CODIFICATION**

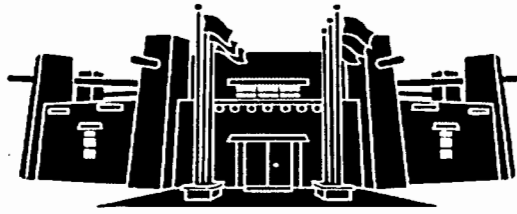
30 The provisions of this legislation which amend or adopt new sections of the Navajo Nation

1 Code shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel
2 shall incorporate such amended provisions in the next codification of the Navajo Nation Code.

3
4 **SECTION TEN. SAVINGS CLAUSE**

5 Should any provisions of this legislation be determined invalid by the Navajo Nation Supreme
6 Court, or the District Courts of the Navajo Nation, without appeal to the Navajo Nation
7 Supreme Court, those portions of this legislation which are not determined invalid shall remain
8 the law of the Navajo Nation.



I write this email/comment in demanding that the Navajo Nation recognize and approve the need for same-sex marriage. Not doing so would only continue to alienate our LGBTQIA+ citizens as well as maintaining a reputation of being "old school" when the United States and many other world governments have already taken the initiative of protecting these freedoms.

As a Navajo Nation citizen, I understand those who might oppose this legislation might argue that we're simply doing it in the name of tradition but one can't help but ask: Whose tradition? That of the Navajo People or that of the Christian faith that came from overseas? There is no way of knowing what our ancestors felt regarding LGBTQIA+ (Two-Spirit) people because like many things, such knowledge was lost during the time of war, dislocation, and disease inflicted by those who sought to colonize our land. Not recognizing same-sex marriage in the name of tradition allows for the suppression of Native people to continue and it is my hope that we will not show the rest of the country/world that we still allow antiquated concepts to flourish.

Apart from tradition itself but in relation to its name, I would implore members of the Navajo People, Council and President Nygren's administration that adopting a policy in the name of any one faith only serves to invite favoritism which only invites division. This country is already divided enough on many issues and I would hate to see it fester on the Navajo Nation as well. Faith is a positive aspect when one seeks guidance and/or reassurance when we go about our lives but we should not use it to dictate the lives of others. History has gone to show the repercussions when any government implements policy based on religion and those results often end in conflict and more often than not; bloody. We as Indigenous People of the "Americas" should know this fact more than most because we've been fighting it for the past 5 centuries and we've seen it be the reason why so much bloodshed has occurred across other continents. So when President Nygren or the Navajo Nation Council make their decision to the legalization or outlawing of same-sex marriage, I would ask them not to make it based upon faith.

The Navajo Nation has a unique opportunity to show the country, the world, and all other Native Nations that we are a tribe of love, acceptance and freedom. Let us not squander such a chance. It is often said that we should "Walk in Beauty" but such a saying is not appropriate when we shame or exclude a portion of our People simply based on their orientation; an identity that they did not choose but were simply meant to be as individuals and who are we, or anyone, to question that reality? If we are truly healing as Native people of our traumas of the past, then recognizing this right should be a testament to that movement.

I sat in many ceremonies and among the elderly in their chatter. Never did I hear of homosexuality and queerness as a sacred way of living. It was shameful to our people. Something that was hidden and that life was equated with being out of balance. I never heard of being two spirited as a positive but that it was shameful.

How are we to progress as a matriarchal society if we give in to the dominant society's woke demands. Why do we have to give in to everything to be considered civilized?

I have a son who is transgender and I love him dearly but I will not give into his demands because he "feels" a certain way. RESOLUTION OF TEEC NOS POS CHAPTER

TNPCH-06-26-2023-R-86

**AN ACTION TO OPPOSE THE 25TH NAVAJO NATION COUNCIL
LEGISLATION NO. 0139-23 ON THE GROUNDS OF THE LACK OF NAVAJO
PEOPLES' INPUT AND THE CHAPTER GOVERNMENTS LACK OF
CONSENT AND SUPPORT**

WHEREAS:

1. Pursuant to 26 N.N.C., Section 3 (A) the Teec Nos Pos Chapter is a duly recognized certified chapter of the Navajo Nation Government, as listed at 11 N.N.C., part 1, section 10 and
2. Pursuant to 26 N.N.C., Section 1 (B) Teec Nos Pos Chapter is vested with the authority to review all matters affecting the community and to make appropriate correction when necessary and make recommendation to the Navajo Nation and other Local agencies for appropriate actions; and
3. The Teec Nos Pos Chapter vehemently opposes Legislation 0139-23: *An Act Relating to the Health, Education and Human Services, Law and Order, Budget and Finance, and Naabik'iyáti' Committees and the Navajo Nation Council; Repealing 9 N.N.C. § 2(C) of the Diné Marriage Act of 2005, to Uniformly Recognize All Marriages Within the Navajo Nation; and Amending Other Provisions in Title 9 of the Navajo Nation Code Related to Marriage Within the Navajo Nation*, and
4. On April 22, 2005, the 20th Navajo Nation Council unequivocally passed the Diné Marriage Act with a vote of 67-0-0, that unmistakably codified the following language, "Marriage between persons of the same sex is void and prohibited" in Navajo Nation Council Resolution CJN-34-05; and
5. The former Navajo Nation President Dr. Joe Shirley, Jr., vetoed the April 2005 Navajo Nation Council resolution to prohibit marriage between same-sex couples, he wrote to the council that, "It is the responsibility of the Navajo people to raise the question and address it through an initiative – rather than the then 88 delegates determining the outcome;" and
6. The Teec Nos Pos Chapter (*community members*), regardless of faith whether Christians, Native American Church, or Diné Traditional Practitioners and Cohorts, is unified in support that any notion of "same sex" marriage in Navajo society is a blatant violation of morality and righteousness in each of our respective faith and doctrine; and,
7. On March 21, 2022, the former Navajo Nation Council Delegate Eugene Tso (Chinle) introduced Legislation 0054-22: *An Act Relating to Health, Education and Human Services, Budget and Finance, Law and Order, and Naabik'iyáti' Committees and the Navajo Nation Council; Repealing 9 N.N.C. § 2(C) of the Diné Marriage Act of 2005 to Acknowledge and Recognize Marriage Equality Among All People; Amending Common-Law Marriage Criteria at 9 N.N.C. § 4(E); Amending Marriage License Form to be Gender Neutral at 9 N.N.C. § 7; Amending Husband and Wife Section at 9 N.N.C. § 201 et. seq. ; and*
8. The Teec Nos Pos Chapter's former council delegate Ms. Charlene Tso was a co-sponsor to Legislation 0054-22 (along with Delegates Eugenia Charles-Newton and Carl Slater), and our

elected representative to the 24th Navajo Nation Council never informed the constituents of this chapter (as well as Aneth, Red Mesa, To'likan, and Mexican Water) regarding her intent and action to co-sponsor such a controversial legislation and our community input was never sought, thus we view this as a grave disrespect to devoid our consent without our knowledge; and

9. On April 26, 2022, Legislation 0054-22 was withdrawn by the sponsor due to its deep controversy and the overwhelming favor by the 24th Navajo Nation expressing that such action should be put before the Navajo people via a referendum as opposed to 24 member council; and

10. In March 2022, former Navajo Nation President Jonathan Nez said, "The Diné Marriage Act is an issue that deeply impacts many of our people, families and our overall society. It's a conversation that should be inclusive of all of our Navajo people and a decision left to the people, especially our elders, not just 24 delegates;" and

11. The Teec Nos Pos Chapter is of a firm belief that the Navajo Nation indeed exerts and exercise its "inherent sovereign powers" to NOT regulate the time-immemorial Diné philosophical values and customs regarding domestic relations that vigorously restricts "same-sex marriage" – a lewd act that is preordain down the path of a coyote-way traveling north toward the permanent doom of the Navajo lifeway; and

12. The Teec Nos Pos Chapter appeals to the sponsor of Legislation 0139-23 and other delegates who support this legislation to heed to the vast Navajo people who do not support this and at a minimum, some form of Town Hall Meeting or Public Outreach or Forum should first be conducted; and

13. The Teec Nos Pos Chapter strictly objects to the adoption of off-reservation and non-Navajo customary values, such as, "same sex marriage," "LGBTQ+" and "Senate Bill 788") into our Diné society; and

14. The Teec Nos Pos Chapter mandates the 25th Navajo Nation Council to put forth a referendum to recognize that the Navajo People are the governing body of the Navajo Nation, and the People should decide this issue through a referendum; and

15. The Teec Nos Pos Chapter stands with the multitude of thousands of Navajo people that this matter should be presented to the Navajo electorate through a referendum; and


16. Lastly, the Teec Nos Pos Chapter has little faith in the newly elected council delegate to the 25th Navajo Nation Council to adequately represent our voice and vote on this critical matter, and thus the chapter enacts this resolution independent of our delegate's vote, so to object to Legislation 0139-23.

NOW, THEREFORE BE IT RESOLVED THAT:


1. The Teec Nos Pos Chapter vehemently opposes Legislation 0139-23; and



The same sex marriage has been brought forth to the Navajo Nation Legislation. As a Christian, the same-sex marriage is against our religious beliefs. As Navajo Nation Leaders, I strongly encourage you to listen to our Christian values and make the right choice for our people.

The following are the reasons Christians oppose same sex marriage:

Marriage matters to God. God made man and woman. "It says, "For this reason, a man will leave his father and his mother and will live with his wife. The two will become one. So they are no longer two but one. Let no man divide what God has put together" (Matthew 19:4-6).

Marriage was invented by God and not by man. We have neither the authority nor the ability to change what marriage is. "Therefore shall a man leave his father and his mother, and shall cleave unto his wife and they shall be one flesh" (Genesis 2:24). Executive Director, Office of Legislative Services:

Homosexuality is not a topic that is readily discussed within the traditionally confines of the Navajo Nation. Neither is same-sex marriage so these topics can ignite definite pro- and con- responses. When Seth Damon states, in many of his interviews, "...I'm sponsoring is to ensure that all Diné are welcome within the four sacred mountains...", I strongly believe all Diné are welcomed but some may not feel accepted due to various reasons, not only because of their sexual origin.

The Navajo Nation Legislation has explicitly banned same-sex marriage since 2005 and it remains in effect even though attempts to amend this act have failed. A concern with such an important subject is that it is the responsibility of the Council Delegates to inform and have the Navajo people be included in the conversation, be allowed to have their input (more than 5 days), and the decision left to the People, including our Elders, through an initiative, and not just the 24 delegates determining the outcome.

Another point of consideration is the gay community has not really made the 'argument' as to how it 'does not uniformly welcome or support the well-being of *all* Diné' as stated in the amendment? What is heard is "We want what you have, and therefore you should give it to us" but there is nothing stated as to why this is beneficial to the Navajo people, culture, or what possible impact this amendment would have on heterosexual marriage and what the impact would be on children. There is no real information, that I am aware of, about what this amendment would do to the moral preservation of the Navajo Nation, what it would do to religious liberty, what it would do to the mental and physical health of children. The possible consequences to the Navajo Nation as a whole are an important aspect to consider, such as who we are as a People, what we stand for, what we teach our children, what our values and ethics are, etc.!

I believe it is safe to say that most of the Navajo Nation People do not approve of same-sex marriage, but many are uncomfortable about it because, the public perception is if a person feels that way, then they are a bigot or a hater. And if the culture continues to send that message, if our educational system sends that message, which it does, eventually the culture will change and people's opinions will change. When a person is devalued in that manner, you get less of it. When you get less of it, society as a whole suffers. Compelling people to violate their conscience is not permissible or constitutional. Expressing tolerance of people of faith who have a sincere religious belief in favor of traditional marriage, is not acceptance since tolerance should be across the board, in all directions. All people need to freely exercise their faith as part of the First Amendment's protection.

It is already a difficult environment for children on the Navajo Nation today, from the traditional Navajo culture/tradition, as well as from the Judeo-Christian perspective. Marriage is a sacred union between a

man and a woman. What is best for children, is a mother and a father who are the parents of that child, raising that child in a stable, married relationship.

Freedom of religion still needs to be upheld! The amendment does not state specifically how religious groups that oppose same-sex marriage will be shielded from providing "any services, facilities, or goods for the solemnization or celebration of a marriage". Will the amendment also prevent churches and religious nonprofits that decline to recognize same-sex marriage from having their tax-exemption status altered or stripped? Passage of this amendment would put People with certain sincere religious beliefs at greater legal risk.

It is good to see that traditional Navajo weddings are considered sacred and will not be impacted by the possible same-sex amendment. This same decree needs to be extended to those religious groups that oppose same-sex marriages.

One last note, in my experience as I was growing up here in Lukachukai, it was my understanding that "Nádleehí" were consider 'sacred' people, revered and never married. As a child I was introduce to 2 such individuals and they were male. They did perform in a 'female' role by caring for the mother of the family, doing household chores and domestic activities. They never spoke, were quiet and often hidden behind the mother. They brought no attention to themselves.

Do allow the Navajo People to be the final decision-makers of this Amendment!!



Dear Honorable Council Delegates,

I am an enrolled member at Kayenta Chapter, an active voter, and a homesite lease owner on the Navajo Nation. Today, I am respectfully submitting my comments to support Legislation 0139-23. It is high time that our council sends a message to every Navajo Lesbian, Gay, Bisexual, Transgender, Queer, Intersex, Asexual, and 2 Spirit (LGBTQIA2+) person that we support them. We love you. We care for you. We honor you. We respect you.

As a Diné woman, I was shocked by the justification and rationale during last year's discussion around the Marriage Equality act that prevented the law from being passed within our Navajo Nation. It is clear, there are continued misunderstandings and confusion about who our LGBTQIA2+ relatives are and their rights as human beings. We also see this antagonism on a national level as we observe states banning certain books and materials to be taught in classroom because they are believed to promote and condition children to become LGBTQIA2+. It is clear, there is a deep ignorance of who LGBTQIA2+ people are. We must educate ourselves.

In our Navajo traditional stories, we learn and teach about the history of the Naadleeh and the role that LGBTQIA2+ Navajos have played in helping all of the people survive and flourish from the monsters to our current roles now. We must challenge the violence against our LGBTQIA + relatives.

When we tell people that their love is not right, or is not part of our traditional history, we are enacting a colonial behavior of conquer and divide. We are tremendously fragmented as a people and telling our people who they may love will continue to erode our Navajo Nation's basic code of our relationship, k'é. Our government must be a tool to help heal our nation, unite our people, and push back against efforts to fragment our people. We must place unconditional love as a driving

force of our government.

If we repeatedly say something is not right, then we permit micro-aggressions against our own relatives. When I say microaggressions, these are statements that dismiss the lived experiences of our people. These microaggressions can lead to micro assaults or even micro insults. Meaning that statements and behaviors that convey bias or communicate negative attitudes toward our own Navajo relatives. We know when these micro acts occur, they impact our self esteem, they fuel anger, and create division among our Navajo relatives.

So, to our dearest leaders and community members, I want a future where we honor the uniqueness and diversity of our people. Currently, our Navajo Nation council is such a beautiful blend of LGBTQIA+ members, mothers, fathers, grandparents, medicine people, lawyers, doctors, professors, farmers, ranchers, and artists. I am respectfully asking you to support and pass the Diné Marriage Equality Act.

We are members of the Church Rock Christian Reformed Church that serves the community of Church Rock Chapter, Church Rock, NM and surrounding areas. Since our ministry is in Church Rock, we feel fortunate to be a part of the constituency in District 16. As part of the community, we stand with citizens who are expressing their support with signatures in the attached petition. This letter concerns the proposed Legislation 0139-23 introduced by Delegate Seth Damon.

As a church, we are disheartened that same sex marriage is continuing to weigh down on the Navajo Nation. Although we are not trying to show hatred or attain some political end, we are concerned that marriage among homosexuals between two males and two females alter and destroy the traditional marriage institution, the natural union between a man and a woman. The proposed Legislation 0139-23 relating to the Dine' Marriage Act of 2005 and provisions in Title 9 of the Navajo Nation Code weaken and disrupt our traditional Navajo kinship (blood relationships); they reduce the value of our clan system. SUBJECT: Legislative No. 0139-23 – Repealing 9 N.N.C. 2(C) of the Dine Marriage Act of 2005. Requesting of Navajo Nation government to rescind this proposed legislation, and in lieu of, enact a legislation requiring a referendum vote by the Navajo Nation voters opposing or approving an amendment to the Dine Marriage Act of 2005 (No. CJN-34-05).

I am writing to you today to request for a referendum vote from the people who have elected you to this office. Under the laws, you represent the people that voted, or not voted for you, into this position. The Legislation (No. 0139-23) introduced by Seth Damon is one of those law that changes and shapes the way marriages are conducted on the sovereign Nation. This major legislation, or similar legislation, require the voices of all the tribally enrolled member of the Navajo Nation people residing on and off the Navajo Nation. It is by a referendum vote in a special election that will accomplish that.

Under the Section Two, Findings in Legis. No. 0139-23 are words and sentences that can be debated since some of the sections are bias and not truthful in nature without real historical discoveries or basis, i.e., Section 2.E, Section 2.G, etc. Furthermore, Section 2.M provide a false statement of "*The Navajo Nation finds it to be in the best interest of the Navajo Nation and the Navajo People to repeal 9 N.N.C. 2(C) so that all person can enjoy the benefits of legal recognition of their marriages within the Navajo Nation, whether our relatives are heterosexual, homosexual, bisexual, transgender, non-gender specific, two-spirit, nadleeh.*"

The latter statement (2.M) will be truthful when the voice of the Navajo Nation voters is heard by a referendum vote. That is all I am asking. Without the voices from the Navajo voters, then the Navajo Nation government is like "clouds without water". Another words, it will be a selfish act.

For the record, the State of New Mexico, had battled similar same-sex law. The legislations were introduced several times and several times were challenged. Many technical and scientific questions were expressed by parties to and against these legislations. At the end, the New Mexico legislators could not agree, so that ended the passage of the same sex marriage law. However, by 2013, the New Mexico Supreme Court issued a landmark Marriage Equality Ruling for Same-Sex Couples. This was a case, Griego v. Oliver – Freedom to Marry in New Mexico, that opened the gateway to same sex marriage. The argument in the court cited Article II, Section 18 of the New Mexico Constitution under the Equal Protection Clause. There were six plaintiffs to the case seeking the freedom of marriage. The 33 New Mexico County clerks then intervened in the lawsuit and filed a petition asking the New Mexico Supreme Court to provide a statewide ruling on whether same-sex couple can marry.

On the Navajo Nation, we do not have a constitution in place, although there is the workable 3-branch of government. New Mexico had the Constitution that created a loop to same sex marriage. In the case of Legislation No. 0139-23 filed by Seth Damon, it is asking of the 24-bodied council delegates to make that decision on behalf of over 400,000 Navajo residing on and off the Navajo Nation land. The 24 council delegates are vulnerable to the election process every four years, thus their decision on these types of critical decision must be made from the Dine people themselves. This can only be accomplished by a referendum vote. The referendum legislation should be clear in its writing so that non-articulate or non-English speakers can understand what they are voting on. That is what I am requesting from you today.

Prohibiting same-sex marriages does not welcome or support the well-being of all our Navajo family members. This comprehensive legislation amends provisions within the Navajo Code that will also protect our women, ensure same-sex couples are protected under the law, and bring an end to LGBTQ+ discrimination.

Let me also be clear that we value and respect the traditional Navajo wedding ceremony involving a man and woman. That shall remain unchanged. We are asking for equal recognition of our state marriage license, the permission to obtain a Navajo marriage license, and to be treated as equally as our straight parents.

Honorable Members of the Navajo Nation Council,

I write to you today not in my official capacity as an Associate Judge for the Pueblo of Zuni but as a concerned member of the Navajo Nation. I wish to provide insight into what I witness daily in court and in my previous role as a sex education teacher. This legislation seeks to repeal the discriminatory Diné Marriage Act and officially recognize marriage equality for all Navajo people.

As a member of our proud Navajo community, I have witnessed the profound impact of discriminatory legislation on the lives of our LGBTQIA+ brothers and sisters. As a sex education teacher in the Navajo Nation, I have had the privilege of engaging with our youth and hearing their experiences. Sadly, many Navajo LGBTQIA+ youths have expressed that they feel unseen and unheard in their own community.

It is crucial that we confront and rectify the injustices perpetuated by laws like the Diné Marriage Act, which not only infringe upon the rights of our community members but also undermine the principles of equality and justice that our Nation holds dear.

It is essential to recognize the historical context of the Diné Marriage Act and its roots in the opposition to homosexuality and gender-fluidity introduced by Christian missionaries and the U.S. federal government, particularly through the Bureau of Indian Affairs. These discriminatory attitudes have no place in a modern and inclusive society. Our culture and traditions have always embraced diversity, and it is time for our laws to reflect this acceptance.

One alarming consequence of such discriminatory laws is the disproportionately high suicide attempt rate among Navajo LGBTQIA+ youths, which is currently three times that of white LGBTQIA+ youths. These statistics should serve as a stark reminder of the devastating impact that discrimination and lack of acceptance can have on the mental and emotional well-being of our young community members.

Furthermore, it is heartening to observe the generational shift in attitudes within our community. Many Navajo LGBTQIA+ youths find acceptance and support from their grandparents' generation, even when they face opposition from their parents' generation. This evolving perspective within our community underscores the need for our laws to evolve to ensure that all Navajo people can live free from discrimination and enjoy the same rights as their fellow citizens.

In my personal capacity as an Associate Judge, I have had the privilege of presiding over name changes for transgender youth and providing a safe space for them to express their identities. These experiences



The Diné Marriage Act not only denies the fundamental human right to marry the person one loves but also perpetuates a harmful stigma against LGBTQIA+ individuals in our community. It is time for our laws to change, reflecting the principles of equality, respect, and acceptance that define our culture.

I urge you, esteemed members of the Navajo Nation Council, to support Legislation No. _____ and take a bold step towards justice, equality, and inclusion for all Navajo people. By repealing the Diné Marriage Act, we can send a powerful message that discrimination has no place in our Nation, and love is love, no matter who it is between.

Thank you for your time and consideration. I look forward to witnessing the positive impact that this legislation can have on the lives of our LGBTQIA+ community members and the Navajo Nation as a whole.





Dear Honorable Council Delegates,

Finding a person to love and to love you back is one of life's biggest challenges. When we tell people that their love is not right, or is not part of our traditional history, we are enacting a colonial behavior of perpetuating a conquer and divided mindset that continues to set us on a fragmented course. We are tremendously fragmented as a people and telling our people who they may love will continue to erode our Navajo Nation's basic code of our relationship, k'é. Our government must be a tool to help heal our nation, unite our people, and push back against efforts to fragment our people. We must place unconditional love as a driving force of our government.

If we repeatedly say something is not right, then we permit micro-aggressions against our own relatives. When I say microaggressions, these are statements that dismiss the lived experiences of our people. These microaggressions can lead to micro assaults or even micro insults. Meaning that statements and behaviors that convey bias or communicate negative attitudes toward our own Navajo relatives. We know when these micro acts occur, they impact our self-esteem, they fuel anger, and create division among our Navajo relatives.

In the Navajo Nation tribal code 1, the Navajo fundamental laws protects all Navajo people and they will be discriminated against their sex and will be treated as an equal human being:

§ 3. Denial or abridgment of rights on basis of sex; equal protection and due process of Navajo Nation law Life, liberty, and the pursuit of happiness are recognized as fundamental individual rights of all human beings. Equality of rights under the law shall not be denied or abridged by the Navajo Nation on account of sex nor shall any person within its jurisdiction be denied equal protection in accordance with the laws of the Navajo Nation, nor be deprived of life, liberty or property, without due process of law. Nor shall such rights be deprived by any bill of attainder or ex post facto law.[1]

It is high time that our council sends a message to every Navajo Lesbian, Gay, Bisexual, Transgender, Queer, Intersex, Asexual, and 2 Spirit (LGBTQIA2+) person that we support them. We love you. We care for you. We honor you. We respect you.

As a Diné woman, I was shocked by the justification and rationale during last year's council discussion around the Marriage Equality act that prevented the law from being passed within our Navajo Nation. It is clear, there are continued misunderstandings and confusion about who our LGBTQIA2+ relatives are and their rights as human beings. We also see this antagonism on a national level as we observe states banning certain books and materials to be taught in classroom because they are believed to promote and condition children to become LGBTQIA2+. It is clear, there is a deep ignorance of who LGBTQIA2+ people are. We must educate ourselves.

In our Navajo traditional stories, we learn and teach about the history of the Naadleeh and the role that LGBTQIA2+ Navajos have played in helping all of the people survive and flourish from the monsters to our current roles now. We must challenge the violence against our LGBTQIA + relatives.

When we tell people that their love is not right, or is not part of our traditional history, we are enacting a colonial behavior of conquer and divide. We are tremendously fragmented as a people and telling our people who they may love will continue to erode our Navajo Nation's basic code of our relationship, k'é. Our government must be a tool to help heal our nation, unite our people, and push back against efforts to fragment our people. We must place unconditional love as a driving force of our government.

Currently, our Navajo Nation council is such a beautiful blend of LGBTQIA+ members, mothers, fathers, grandparents, medicine people, lawyers, doctors, professors, farmers, ranchers, and artists. I am respectfully asking you to support and pass the Diné Marriage Equality Act.




