17	SECTION ONE. AUTHORITY	
18	A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §	
19	102(A).	
20	B. A proposed resolution that requires final action by the Navajo Nation Council shall be	
21	assigned to the Naabik'íyáti' Committee. 2 N.N.C. §164(A)(9).	
22	D. Any enrolled member of the Navajo Nation may renounce his or her membership	
23	through written petition to the President of the Navajo Nation requesting his or her	
24	name be stricken from the Navajo Nation census roll. However, reinstatement of	
25	membership with the Navajo Nation is permitted, provided such reinstatement is	
26	approved by majority vote of the Navajo Nation Council. 1 N.N.C. § 705.	
27	E. To be eligible for membership in the Navajo Nation, an individual cannot be enrolled

30	SECTION TWO. FINDINGS

- A. Nicola L. Atene was previously enrolled with the Navajo Nation, "being of ¾ degree Navajo Indian Blood." See **Exhibit A**, official record containing census number and Certificate of Navajo Indian Blood recorded November 1, 2001 by the Navajo Nation Vital Statistics Manager.
- B. Nicola L. Atene relinquished membership with the Navajo Nation and enrolled with the Duckwater Shoshone Tribe. However, Nicola L. Atene disenrolled with the Duckwater Shoshone Tribe. On April 14, 2021, the Duckwater Shoshone Tribal Council, by resolution number 2021-D-12 officially approved her disenrollment. See **Exhibit B**, resolution of the Duckwater Shoshone Tribe numbered 2021-D-12. By this action, Nicola L. Atene's "benefits and privileges she enjoyed as a member of the Duckwater Shoshone Tribe" were effectively revoked.
- C. On September 25, 2021, the Oljato Chapter, in response to request for reinstatement, passed resolution OLJ09-04-2021-NB4, "SUPPORTING ... REINSTATEMENT OF NICOLA L. ATENE AS A MEMBER OF THE NAVAJO NATION." See Exhibit C, Oljato Chapter Resolution.
- D. Ms. Nicola Lavender Atene is eligible for reinstatement as a member of the Navajo Nation.


SECTION THREE. REINSTATEMENT OF NICOLA LAVENDER ATENE

RESOLUTION OF THE GOVERNING BODY OF THE DUCKWATER SHOSHONE TRIBE

RESOLUTION NO. 2021-D-12

- BE IT RESOLVED BY THE DUCKWATER TRIBAL COUNCIL, the Duckwater Shoshone Tribe is organized under the provisions of the Indian Reorganization Act of June 18, 1934, as amended, to exercise certain rights of home rule and be responsible for the general welfare of its membership; and
- WHEREAS, the Constitution of the Duckwater Shoshone Tribe, Article II Membership, Section 1, (a) states "All persons of Shoshone Indian blood whose names appear on the Carson Agency census roll of the Duckwater Shoshone Indians dated January 1, 1941, or on the Commissioner's memorandums of registration dated November 28, 1940, or February 20, 1950, or April 26, 1966.", and Section 1 (b) states, "All persons of at least one-quarter (1/4) degree Shoshone Indian blood born to a member who is a descendant of the Duckwater Shoshone Tribe and who make application for enrollment in accordance with the enrollment ordinance adopted under Article II, Section 3 of this Constitution"; and
- WHEREAS, the Duckwater Tribal Enrollment Committee determined that in Ordinance for Enrollment, Section 305: Grounds for Disenrollment: B. Failure to meet prescribed enrollment requirements of meeting the Shoshone Indian Blood degree and erroneously enrolled with the Duckwater Shoshone Tribe by the adoption of Resolution No. 03-D-28; and
- WHEREAS, the Duckwater Tribal Enrollment Committee exercised their rights and duty by submitting a recommendation to the Duckwater Tribal Council for action to disenroll Nicola L. Atene, DOB -Enrollment No. as a member of the Duckwater Shoshone Tribe; and
- WHEREAS, any and all benefits or privileges bestowed on Nicola L. Atene as a member of the Duckwater Shoshone Tribe are herein revoked as Ms. Atene is no longer eligible to receive such benefits and privileges; and
- NOW THEREFORE BE IT RESOLVED, that the Duckwater Tribal Council has determined that on recommendation of the Duckwater Tribal Enrollment Committee the Tribal Council has disenrolled Nicola L. Atene as a member of the Duckwater Shoshone Tribe and revoked any and all benefits and privileges she enjoyed as a member of the Duckwater Shoshone Tribe.

BE IT FURTHER RESOLVED, that this Resolution 2021-D-12 shall supersede any and all prior Resolutions and action regarding the enrollment issues for Nicola L. Atene and Resolution No. 03-D-28 is herein rescinded.

RESOLUTION OF THE OLIATO CHAPTER

RESOLUTION NO.: OL109-04-2021-NB4

SUPPORTING RESOLUTION OF THE OLIATO CHAPTER FOR THE REINSTATEMENT OF NICOLA L. ATENE AS A MEMBER OF THE NAVAJO NATION.

WHEREAS;

- 1. Pursuant to N.N.C., § 4001 (D) and 4028 (A)(B), the Oljato Chapter is established and certified a local government entity of the Navajo Nation vested with the authority to review all matters affecting the Chapter and submit appropriate recommendations to the Navajo Nation government or other local agencies by resolution; and
- The Oljato Chapter recognizes that under the laws of the Navajo Nation, any enrolled member of the Navajo Nation may renpunce [his] membership by written petition to the President of the Navajo Nation requesting that his name be stricken from the Navajo Nation roll, 1 N.N.C. §705.
- The Navajo Nation in addition states, "[no] person, otherwise eligible for membership in the Navajo Nation, may enroll as a
 member of the Navajo Nation, who, at the same time, is not enrolled with another Indian tribe, 1 N.N.C. §703.
- 4. The Oljato Chapter also recognizes that renounced members may be reinstated by the Navajo Nation only by the vote of majority of the Navajo Nation Council, 1 Navajo Nation Code § 705.
- 5. The Navajo Nation Office of Vital Records has issued a Certificate of Indian Blood dated November 1, 2001. See attachment, confirming Nicola Lavender Atene was enrolled with the Navajo Nation on November 1, 2001 and provided Navajo Nation Census Number.
- 6. The Navajo Nation Office of Vital Records has further confirmed Nicola L. Atene is three-fourth (3/4) degree Navajo blood and therefore, is eligible for re-enrollment as a member with the Navajo Nation, 1 N.N.C. § 701 (B).
- 7. The Duckwater Shoshone Tribe has confirmed Nicola L. Atene formally relinquished her Duckwater Shoshone Tribe membership on April 14, 2021. See attachment, The Duckwater Shoshone Tribal Resolution No.: 2021-D-12.

NOW, THEREFORE, BE IT RESOLVED THAT:

 The Oljato Chapter supports the request to reinstate, or otherwise re-enroll, Nicola L. Atene as a member of the Navajo Nation. By this action of the and pursuant to the Oljato Chapter and pursuant to the laws of the Navajo Nation, shall be entitled to all rights, benefits and privileges associated with membership with the Navajo Nation.
